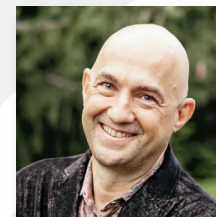

Dr. Fritz is a certified specialist in Periodontics and is in full-time private practice in Fonthill, Ontario. The focus of his periodontal practice is dental implant therapy, microsurgical bone and soft tissue reconstruction, and oral medicine.

Dr. Fritz practiced General Dentistry for 5 years before earning a Fellowship in Periodontics from the Royal College of Dentists of Canada. Dr. Fritz considers the most important part of his clinical training to be the completion of a Ph.D. in the molecular biology of bone formation from the University of Toronto. This provides Dr. Fritz with the ability to approach clinical problems from a rigorous scientific perspective.

Dr. Fritz is an Adjunct Professor in the Centre for Bone and Muscle Health, Faculty of Applied Health Sciences at Brock University, Staff Periodontist for the Niagara Health System, President of the Welland District Dental Society, Past-President of the Ontario Society of Periodontists and a Fellow of the International Team for Implantology (ITI). Dr. Fritz has lectured extensively across North America and Europe and has published many articles and book chapters on the topic of implants and bone health.



There is a myriad of information surrounding dental implant therapy presented from competing viewpoints. This presentation will examine implant dentistry holistically from the perspective of the head, heart and hand.

This presentation will be useful for dentists and their irreplaceable assistants, dental hygienists dutifully maintaining dental implants, and stressed admin team members who field tricky implant questions.

OBJECTIVES OF THE HEAD: How to select the appropriate patient. How to determine the risks and benefits and the potential complications of a case. How to establish informed consent

and what guidelines must never be violated. How long do implants work and what is the guarantee if they fail? The head will be presented through the lens of a lawyer and a scientist.

OBJECTIVES OF THE HEART: What are current timelines for implant therapy? What does the digital workflow look like today to make the patient's experience easier. How do we orchestrate the patient's experience so they become raving fans of your practice. Define the economic costs of a failed implant. The heart will be presented through the lens of an MBA business owner with world-class experience design ability.

OBJECTIVES OF THE HAND: How do you become proficient in implant dentistry? Discuss the options to manage a peri-implantitis or peri-mucositis. Discuss a step-by-step supportive implant maintenance algorithm which your hygiene team should be using. The hand will be presented through the lens of a hygiene instructor and periodontist who has placed more than 9000 implants and has learned from his share of failures.
